I agree that Sourdough Fuel shall not be liable or responsible for any damage resulting from an inadequate supply of fuel in the event of sudden changes in consumption without reasonable notice to Sourdough Fuel, or due to leaks or other loss of fuels not caused by negligence on the part of Sourdough Fuel. I understand if we utilize wood stoves or other sources of heat other than oil, an interruption of such use (i.e. mid-winter vacancies and/or discontinued use of wood or supplemental heating source) will result in an increase in my oil consumption. I agree to give written notice to Sourdough Fuel prior to any interruption and further agree that in the event just notice was not given to Sourdough Fuel, that Sourdough Fuel shall not be liable or responsible for any damage resulting from an inadequate supply of fuel.

In the event I wish to terminate Automatic Delivery Service, I agree to give Sourdough Fuel written notice. If notice is given by mail, then it will be sent Certified or Registered Mail only, postage pre-paid, return receipt requested. Notice of cancellation shall only be effective when received by Sourdough Fuel, as determined by the date of the return receipt. I agree to pay, within ten (10) days of invoice, for all fuel delivered prior or on the same day as notice of cancellation was received by Sourdough Fuel.

**I FURTHER AGREE SOURDOUGH FUEL SHALL NOT BE LIABLE FOR NON-DELIVERY OF FUEL FOR ANY REASON BEYOND ITS CONTROL, INCLUDING WITHOUT LIMITATION PRODUCT SHORTAGE, STRIKES OR WORK STOPPAGES OR SLOWDOWNS, OR WEATHER, OR IF SOURDOUGH FUEL HALTS DELIVERY BECAUSE OF MY FAILURE TO NOTIFY SOURDOUGH OF THE TIMES AND DATES THE DWELLING WILL BE VACANT FOR ANY PERIOD OF TIME OR OF ANY FACTOR THAT WILL ALTER NORMAL FUEL USAGE, FAILURE TO MAKE PAYMENTS ON ACCOUNT, OR FAILURE TO COMPLY WITH ANY OTHER AGREEMENT WITH SOURDOUGH FUEL. IN NO EVENT SHALL SOURDOUGH FUEL BE LIABLE FOR INDIRECT, SPECIAL, OR CONSEQUENTIAL DAMAGES ON ACCOUNT OF THE NON-DELIVERY OF FUEL.**

## CONTRACT OF GUARANTY

This contract of Guaranty is made on the date set forth below, between SOURDOUGH FUEL, INC hereinafter referred to as Sourdough Fuel the undersigned designated as "Guarantor", and the undersigned designated as "Principal Debtor."

WHEREAS, Sourdough Fuel furnished goods and/or services to the undersigned Principal Debtor;

WHEREAS, Principal Debtor is presently or may become indebted to Sourdough Fuel for products and/or services;

WHEREAS, in consideration of Sourdough Fuel commencing or continuing to grant credit and/or sell products or service to the Principal Debtor, Guarantor is willing to enter into this Guaranty agreement;

NOW, THEREFORE, IT IS AGREED AS FOLLOWS:

1. In consideration of Sourdough Fuel selling goods and granting and/or extending future credit to Principal Debtor, Guarantor does hereby guarantee the prompt payment of all debts now due Sourdough Fuel by Principal Debtor as show by the account books of Sourdough Fuel at the date of acceptance of this Contract of Guaranty.
2. This Guaranty is to cover all debts incurred for all products and services sold to Principal Debtor together with all interest and freight charges thereon, if applicable.
3. As further consideration for extension of credit to the Principal Debtor by Sourdough Fuel, Guarantor guarantees full payment of any and all such debts and obligations that may be incurred or may be due and owing Principal Debtor, but not in excess of the total amount due Sourdough Fuel.
4. Guarantor shall have the right to terminate this obligation under this guaranty at any time by giving written notice by certified mail to Sourdough Fuel at least sixty (60) days prior to the effective date of termination. In the event Guarantor gives such notice, Guarantor shall be liable for all guaranteed debts incurred by the Principal Debtor after the sixtieth (60th) day, but Guarantor shall not be liable for the payment of any debts incurred by the Principal Debt up to and including the effective date of termination. All notices shall be sent to Sourdough Fuel by certified mail to 1555 Van Horn Road, Fairbanks, Alaska 99701 or at such place as Sourdough Fuel may designate in writing.
5. Should Sourdough Fuel incur collection costs or attorney fees to enforce any obligation hereunder, the Guarantor agrees to pay Sourdough Fuel such reasonable costs and expenses and attorney fees in addition to and over the limits on this guaranty.
6. Sourdough Fuel need not exhaust its remedies of collection against the Principal Debtor as a condition precedent to liability of the Guarantor without seeking it first from the Principal Debtor.
